

### State Water Resources Control Board Amended Order 3/7/2014

### Upper Russian River Drought Action Plan

#### Introduction

This Drought Action Plan (Plan) has been prepared by the Sonoma County Water Agency (Water Agency) to fulfill the requirements of Term 8 of the State Water Resources Control Board (State Board) amended Order dated March 7, 2014 (amended Order).

Term 8 of the amended Order directs the Water Agency to take the following actions:

To further preserve storage in Lake Mendocino and support the development of the long term reliability study of Lake Mendocino, the Water Agency shall develop a drought action plan. At a minimum the plan shall include:

- a. A detailed schedule with planned completion dates for key events;
- b. A description of how diversions under Permits 12947A, 12949, 12950, and 16596 will not impact Lake Mendocino storage and a list of commitments to avoid impacts;
- c. An explanation of SCWA's authority or other ability to impose mandatory water conservation measures and identification of the persons and entities subject to that authority;
- d. Identification of Russian River water users who are not subject to SCWA's authority to impose mandatory water conservation measures; and
- e. Descriptions of coordination efforts with upper Russian River agricultural and municipal water users to determine water conservation goals (identified in percent reduction), implement immediate mandatory conservation measures, reduce water demand, identify other sources of water supply, and prevent the waste, unreasonable use, unreasonable method of use, or unreasonable method of diversion of water from the upper Russian River.

Each of these components of the Plan is described below.

### 8.a. - Schedule for Drought Coordination Events

On February 3, 2014, the Water Agency hosted a meeting in Hopland, California with upper Russian River municipal water managers to discuss Lake Mendocino water supply. Attendees included representatives of each of the agencies listed in Term 17 of the State Board Order dated May 21, 2013, two members of the Board of Supervisors of Sonoma County, two members of the Board of Supervisors of Mendocino County, and Water Agency staff. Topics discussed during the meeting included:

- A description of the State Board Order dated December 31, 2013;
- A discussion of Lake Mendocino storage scenarios based on various potential hydrologic conditions;

- A discussion of water demand management actions that are available to the upper Russian River municipal water providers; and
- A roundtable discussion by each of the municipal water providers of voluntary and mandatory water demand reduction measures that they plan to implement.

Additional meetings with upper Russian River municipal water managers are scheduled for April 10, 2014, late May to mid June 2014 and late July to mid August 2014. Topics to be discussed during these future meetings will include:

- Update on the hydrology and water supply conditions of Lake Mendocino;
- State and federal activities related to drought funding opportunities;
- Updated Lake Mendocino storage scenarios based on various potential hydrologic conditions;
- Coordination efforts that potentially could result in the Water Agency managing river flows with a lower operational buffer; and
- Update by municipal providers on voluntary and mandatory water demand reduction measures that have been implemented.

The Water Agency also has been coordinating drought activities with upper Russian River agricultural stakeholders. Unfortunately, this group of upper Russian River water users is decentralized and not represented by a single agency. Consequently, information sharing and coordination activities with the entire stakeholder group are difficult to implement.

To date, presentations by Water Agency staff have been made during the following drought forums and meetings, to attempt to outreach to agricultural stakeholders:

- February 4, 2014 Joint Sonoma/Mendocino County growers meeting that is hosted annually before the frost season;
- February 11, 2014 Meeting with members of the Sonoma County Winegrape Commission, United Wine Growers of Sonoma County and the Sonoma County Farm Bureau; and
- February 18, 2014 Meeting with members of the Sonoma Winegrape Commission, United Wine Growers for Sonoma County and the Sonoma County Farm Bureau.

The presentations included a summary of the hydrologic conditions that have led to extremely low storage levels in Lake Mendocino, a discussion of the Water Agency's Temporary Urgency Change Petition and the State Board Order approving the petition, coordination efforts with upper Russian River municipal water managers, and coordination efforts with National Marine Fisheries, California Department of Fish and Wildlife and State Board staff.

Additional meetings with upper Russian River agricultural stakeholders from Mendocino and Sonoma Counties are scheduled for April 2 and 3, 2014. Topics to be discussed during these meetings will include:

- Coordination during the frost season for improved management of upper Russian River flows;
- Use of improved frost forecasting tools recently developed by the National Oceanic and Atmospheric Administration's Earth System Research Laboratory; and
- Opportunities for water demand reductions during the irrigation season.

# 8.b. - Description of How Lake Mendocino Diversions Under Permits 12947A, 12949, 12950 and 16956 Will Not Impact Lake Mendocino Storage

The Water Agency's water supply operations are authorized by four water rights permits: Permit 12947A (A012919A), Permit 12949 (A015736), Permit 12950 (A015737), and Permit 16596 (A019351). Permits 12947A and 16596 authorize diversions to storage in Lake Mendocino and Lake Sonoma respectively, and rediversions of water released from storage and direct diversions at points downstream. Under Permit 12947A, the Water Agency controls releases from Coyote Valley Dam on the East Fork of the Russian River, diverts water to storage in Lake Mendocino's conservation pool, and passes through water to satisfy diversions under senior water rights. Under Permit 16596, the Water Agency controls releases from Warm Springs Dam on Dry Creek, diverts water to storage in Lake Sonoma's conservation pool, and passes through water to satisfy diversions under senior water rights. Permits 12949 and 12950 are direct diversion permits that authorize diversions from the Russian River at various points on the river downstream of its confluence with Dry Creek.

Under the Water Agency's normal operating protocols, the Water Agency uses releases from Coyote Valley Dam to support demands and maintain minimum instream flows in the upper river down to its confluence with Dry Creek, and the Water Agency does not adjust these releases to meet instream flow requirements in or diversions from the Russian River downstream of its confluence with Dry Creek. However, since the 2008 issuance of the Biological Opinion (BO) by the National Marine Fisheries Service, releases from both dams are subject to incidental take criteria in response to the BO's findings of jeopardy to the endangered and threatened salmonids. These criteria have a more profound effect on limiting releases from Lake Sonoma than on limiting releases from Lake Mendocino. As a result, during the months of June through October, the Water Agency has occasionally deviated from these normal operating protocols and has made additional releases from Coyote Dam to minimize incidental take exceedances on Dry Creek.

While drought conditions exist on the upper river, the Water Agency is committed to minimizing impacts on Lake Mendocino and will reduce deviations from these normal operating protocols for Lake Mendocino operations. The BO has provided for several allowable exceedances of the incidental take criteria, and the Water Agency will utilize these exceedances in lieu of increasing releases from Coyote Valley Dam this year, as feasible. This action would

limit Water Agency diversions from the Russian River downstream of Dry Creek to rates that that do not require any additional releases from Coyote Valley Dam.

The only active authorized points of diversion on the Russian River between Lake Mendocino and the river's confluence with Dry Creek in the Water Agency's permits are the points of diversion for the City of Healdsburg, which has a water supply agreement with the Water Agency. Historically, the City of Healdsburg has not made diversions under this agreement and Permit 12947A, but has diverted water under this agreement from Dry Creek during the winter season (under Permit 16596). The City of Healdsburg does, however, have its own water rights for diversions from the Russian River and makes most of its diversions under those rights. Water Agency staff have been in discussions with City staff and have requested that not only should the City refrain from diversions under the City's agreement with the Water Agency and the Water Agency's Permit 12947A, but also that the City should shift its production as much as possible to its sources on Dry Creek, to reduce demand on Lake Mendocino.

Additionally, the Redwood Valley County Water District (Redwood Valley) production facility in Lake Mendocino is an authorized point of diversion in the Water Agency's permit. However, at this time, the Water Agency does not have an active water supply agreement with Redwood Valley.

Under these proposed conditions, stored water would continue to be released from Lake Mendocino to satisfy diversions under Permit 12947B by contractors of the Mendocino County Russian River Flood Control Water Conservation Improvement District (RRFC) and diversions in Sonoma County by water rights holders under the 10,000 ac-ft reservation in State Board Decision 1030, and to meet minimum instream flow requirements for the Russian River upstream of the river's confluence with Dry Creek.

Under drought conditions, a larger portion of the upper river flows are derived from Water Agency releases of Project water from Lake Mendocino. Water rights holders that are accustomed to non-Project water being available during a normal year may be diverting Project water this year, even though this water is not available for diversion under their water rights. This situation likely occurs every year, but its occurrence is more pronounced in a drought year. Because most water rights holders do not track the details of availability of non-Project water, the Water Agency recommends that the State Board notify all water rights holders that are not entitled to divert Project water of the limits of their water rights. The Water Agency tracks when Project water releases are being made in the upper river and posts this information on the Agency's website. When Project water releases are occurring, any downstream diversions of natural flow result in increases in the amounts of Project water that must be released and thereby result in reductions in the remaining amounts of stored water in Lake Mendocino. While the Agency does not have the authority to issue notices or restrict such diversions, the State Board could take such actions.

## 8.c. - An Explanation of the Water Agencies Authority to Implement Mandatory Water Conservation Measures and Identification of Persons and Entities Subject to that Authority

The Water Agency has no authority to impose mandatory water conservation measures on, or to limit the diversions of, agricultural diverters or municipal diverters of Russian River water that do not have contractual relationships with the Water Agency. Currently, only the City of Healdsburg has a contractual agreement with the Water Agency for diversions from the Russian River upstream of its confluence with Dry Creek. As discussed above, in addition to the water supply agreement with the Water Agency, the City of Healdsburg also has its own water rights on the Russian River and predominantly diverts under those rights. Consequently, the Water Agency only has authority to limit the City's diversions from the Russian River if it is diverting water under the water supply agreement with the Water Agency. The Water Agency does not have the authority to impose mandatory water conservation measures on the City on its own, but the City would be required by their agreement with the Water Agency to abide by any water conservation measures imposed on the Water Agency. To reduce impacts to Lake Mendocino storage due to municipal diversions by the City of Healdsburg, the Water Agency has encouraged the City to divert water from its point of diversions on Dry Creek under the water supply agreement with the Water Agency.

The Water Agency has additional water supply agreements with entities on the Russian River downstream of its confluence with Dry Creek. These include the Windsor Water District, Camp Meeker Recreation and Parks District, and the Russian River County Water District. Similar to the City of Healdsburg, these water providers are required to meet any water conservation terms imposed on the Water Agency, but the Water Agency does not have the ability to impose conservation measures under its own discretion.

## 8.d. - Identification of Russian River Water Users Who Are Not Subject to the Water Agency's Authority to Impose Mandatory Conservation Measures

As discussed above, the Water Agency has no authority to impose mandatory water conservation measures on, or to limit the diversions of, agricultural diverters or municipal diverters of Russian River water that do not have contractual agreements with the Water Agency. Other than those water providers listed above, the Water Agency has no contractual agreements with any other Russian River water users. Attachment A contains a list of Russian River water rights holders that was compiled from a July 2012 copy of the State Water Resources Control Board's Electronic Water Rights Information Management System (eWRIMS) database.

8.e. – Description of Coordination Efforts with Upper Russian River Agricultural and Municipal Water Users to Determine Water Conservation Goals, Implement Immediate Mandatory Conservation Measures, Reduce Water Demand, Identify Other Sources of Water Supply, and Prevent the Waste, Unreasonable Use, Unreasonable Method of Use, or Unreasonable Method of Diversion of Water from the Upper Russian River

As discussed above (see 8. a. above), the Water Agency has been coordinating with both municipal water managers and agricultural stakeholders on the upper Russian River to take appropriate actions to manage storage levels in Lake Mendocino. Below is a list of actions that have been implemented by upper Russian River water users to reduce their water demands and to improve storage in Lake Mendocino.

On January 21, 2014, Healdsburg's City Council adopted a resolution implementing Stage 2 mandatory water conservation measures and practices. This stage of the water conservation plan seeks a 20 percent reduction from water consumption in 2013.

On January 29, 2014, the City of Cloverdale City Council adopted a resolution implementing Stage 2 mandatory water conservation measures. This stage of the water conservation plan seeks a 25 percent reduction from water consumption in 2013. If the target savings are not achieved, the City may enact Stage 3 Mandatory Reductions which allocates 65 gallons per person per day to each household.

In February 2014, the City of Ukiah posted the following drought statement by their City Manager, Jane Chambers on the city's website.

"There has been much talk about the weather—or lack thereof—this season. We're experiencing one of the driest seasons on record, and readers are no doubt aware of the emergency drought declarations that have been made at both the State and County levels.

While many water districts in Mendocino County are potentially facing serious consequences if rain doesn't come soon, the City of Ukiah has adequate water resources to continue to serve its constituents at the normal "winter water" rate. City of Ukiah water customers use about 2 million gallons of water a day in the winter, a time when there is usually minimal landscape and outdoor

watering. This use is supplied from the city's wells. Summer use swells by another 4 million gallons a day, when landscaping is being watered. City staff will be taking a contract to City Council on April 2<sup>nd</sup> for the award of a contract for the design of a new water well, known as Well #9. It is anticipated that the well could be constructed and online as soon as August

The city relies on water from the Russian River to make our summer water supply available, and that supply is in question as the drought continues unabated. City customers have been called upon to conserve water use since the City called for Stage One voluntary restrictions during the drought of 2009. The City is making progress towards implementing the preferred alternative from the Recycled Water Feasibility Study. CEQA is complete and grant funds are currently being sought as well as budgeted fund in the City's Sewer Capital Improvement Fund."

On March 17, 2014, Healdsburg's City Council adopted a resolution allocating \$30,000 to Water Use Efficiency programs. In addition, Healdsburg is working closely with Water Agency water conservation staff to coordinate drought outreach messaging and grant funding opportunities.

On March 24, 2014, RRFC adopted a resolution reducing its water supply contracts by 25 percent. The District also adopted a resolution to provide Redwood Valley up to 355 acre-feet of water to meet its municipal human health and safety needs. This amount is based on an analysis performed by the District and the California Department of Public Health of the amount necessary to provide 80 gallons per day per capita in Redwood Valley's service area.

Through the North Coast Integrated Regional Water Management Plan, the Water Agency is coordinating with upper Russian River municipal water users on drought funding opportunities that have been made available through emergency drought legislation, Senate Bill 103 and Senate Bill 104. Of the \$200 million in Proposition 84 Integrated Regional Water Management funding accelerated for drought-related projects, approximately \$8 million has been allocated to the North Coast Region. The Water Agency is coordinating a regional grant application for North Coast IRWMP Drought Relief Funding to provide direct incentives to water customers in the upper Russian River. The grant application will be in coordination with City of Cloverdale, City of Healdsburg, Redwood Valley and other upper Russian River utilities and water users.

The Water Agency is also facilitating the launch of a conservation program for the upper river. The program includes outreach and education through a media campaign and, if grant funded, the program will include direct customer incentives to reduce water demands. The Water Agency will be meeting on April 10, 2014 with upper Russian River water mangers to further the conversation.

The Water Agency has provided the 'There's a Drought on, Turn the Water Off' campaign materials for upper river water managers to customize for their actions to attempt to engage their water users in water conservation. The Water Agency has provided low-flow showerheads, kitchen aerators, bath aerators and toilet leak detection tablets to the City of

Healdsburg and the City of Cloverdale. Other upper river utilities can request low-flow hardware from the Water Agency. The City of Cloverdale is implementing the Water Off campaign and distributed low-flow hardware at the Cloverdale Citrus Fair and at City Hall.
