## Agenda:

- **1. Opening/Introductions.** Chase Takajo called the meeting to order at 1:05 p.m. Attendees self-introduced. The Committee quorum was not present.
- 2. Public Comment on Agenda Items. No public comments. Sonoma Water announced that the order of agenda items 4 and 5 would be switched. Arthur Deicke indicated that having

more than one annual Committee meeting, and receiving mid-year project updates, would be helpful.

- **3.** Approval of Meeting Minutes. Due to the lack of a quorum, a vote to approve previous meeting minutes was not held.
- 4. Hydrologic and Hydraulic Modeling for the Central Sonoma Watershed Project (CSWP). Aaron Fulton presented an overview of recent modeling updates and calibration results for the CSWP and Matanzas Dam Rehabilitation Project. The purpose/need, current status, implementation challenges, and relation with the City of Santa Rosa's Federal Emergency Management Agency (FEMA) Flood Risk Remapping Project were also described. A brief discussion followed the presentation. The presentation slides are on file.
- 5. FEMA Flood Risk Remapping Project. Claire Meyers and Flannery Banks presented an overview of the project, which will assess current flood risks and produce and adopt an updated FEMA flood map for the City of Santa Rosa area. The project purpose, impacts, benefits, process, and timeline were described. A brief discussion followed the presentation. The presentation slides are on file.
- 6. Countywide Flood Risk Management Assessment. Sasha Ponomareva presented an overview of the project, which will identify gaps in flood risk services across Sonoma County and develop recommendations for a more comprehensive and integrated countywide flood management and adaptation strategy. The project goals, participating agencies, funding sources, findings to date, next steps, and schedule were described. A brief discussion followed the presentation.
